## LIFE-LONG FIGHT

(Mail and Empire).  
A charge of demanding a bribe of \$2,000 for the purpose of assisting the passage of a bill in the New York legislature has been made against Senator Stilwell, and is now being investigated.

The bill was one to incorporate the New York Exchange. It was being resisted by the exchange, which in its unincorporated position enjoys certain privileges that it would lose were it to be incorporated. The Pujol committee had recommended that the exchange be incorporated, but it does not appear that there was any great public demand for the incorporation.

Now that the story has come to light of the long struggle behind the efforts of one man, George H. Kendall, to make the exchange incorporate it is interesting to note that he is being fought and perhaps with no other desire than that Kendall should receive fair treatment for the demand for incorporation. All above said may grow so strong that it cannot be safely resisted.

The Bank Note Trust  
Kendall is president of the New York Bank Note company, and says that ever since he began business the exchange has boycotted him and has favored the American Bank Note company, which is described as the "Bank Note Trust." Kendall has found no redress against the exchange, whose organizers on more than one occasion have refused to list stocks that his firm engraved. The exchange, it appears, has this arbitrary power, and is reluctant to keep the chief lithographing and engraving business away from Kendall. An example is found in the case of the two bond issues of New York City, signed for \$128,000,000, which the Kendall firm engraved. Mayor Gaynor was notified that the bonds were given to Kendall but he would not be listed on the exchange, and they have not been listed. Gaynor, however, is a fighter and he has joined Kendall in the fight to have the exchange incorporated, declaring it to be outrageous for the City of New York to be at the mercy of the governors of the exchange.

Exchange Favours Trust  
Kendall's first brush with the exchange was in 1875, when he organized the Kendall Bank Note company, and at once set out to get some of the business of the firms listed on the exchange. He found that all the best engraved property, and after submitting specimens, all of them discarded for one reason or other. Kendall was so grieved that he decided to start a new company, and he did so. He called it the Consolidated Stock Exchange. At that time a rival of the New York Stock Exchange, if Kendall did not get fair treatment in the American Bank Note company, were prominent members of the exchange. Putting the Spruce On  
However, although Kendall was allowed to print stock certificates, he found himself hampered in many little ways, and on more than one occasion was obliged to destroy a whole issue and duplicate it because the exchange people found some trifling defect in the issue. Kendall, however, was so much wiser than those of the American Bank Note company, that he decided to start a new company, and he did so. He called it the Consolidated Stock Exchange, and he did so.

A Suit for \$5,000,000  
These friends, in the interests of their own pockets, endeavored to have the New York Bank Note company as the concern was then called, "put in right" with the governors of the exchange, but the fight was so long and so bitter that Kendall appealed to the public against the treatment that he had accorded him, and the exchange, in self-defence, issued the embargo against certain foreign companies to make it appear that there was no discrimination, and that Kendall was merely a "sorehead" who could not do the right kind of work.

In 1909 Kendall brought suit against the exchange for \$5,000,000, which action now is pending. In 1911 his company competed for the contract of engraving and printing the New York City bonds, already mentioned, and was awarded the tender, with the result that the exchange refused to list the bonds. The matter was brought to the attention of the Pujol committee, which investigated the "Money Trust," and found that Kendall was recommended that the matter might be settled if the New York Stock Exchange were incorporated. A bill of incorporation was accordingly introduced, and now Mr. Kendall says that Senator Stilwell wanted \$2,000 to have the bill advanced in committee.

## SOME MYSTERY TO THIS EVENT.

Two Men Dropped Suitcases and Ran When Addressed by Doctor.  
Kansas City, April 20.—Two young men, each carrying a suitcase, walked down Eighth street yesterday afternoon. At the corner of Eighth and Cherry streets stood Dr. V. A. Bucher, who lives at the Arnet Hotel.

"Why, hello, Frank," he exclaimed as they passed him, thinking that one of the young men was his brother.

Instead of answering both young men dropped their suitcases and ran. A crowd headed by Joseph Lesley, a hairdresser, chased the men through several downtown streets, but they escaped.
