Mr. Drew: Mr. Speaker, I think that the attention of the house should be drawn to the fact that these four questions that have just been passed have been standing on the order paper now for six weeks. Mr. McCann: The answers will be given prior to the estimates.

Mr. McCann: I should think that the hon. member who has put the questions on the order paper would be the one most concerned with reference to the time of the answers.
