Ways and Means

Motion agreed to and the house went into committee, Mr. Robinson (Simcoe East) in the chair.

Mr. Harris moved:

Resolved, that towards making good the supply granted to Her Majesty on account of certain expenses of the public service for the fiscal year ending 31st March, 1956, the sums of \$2,055,741,938.07, \$147,724,276 and \$500,000 respectively, be granted out of the consolidated revenue fund of Canada.

Motion agreed to.

Resolution reported, read the second time and concurred in.

Mr. Harris thereupon moved for leave to introduce Bill No. 510, for granting to Her Majesty certain sums of money for the public service of the financial year ending the 31st March, 1956.

Motion agreed to, bill read the first and second times, and the house went into committee thereon, Mr. Robinson (Simcoe East) in the chair.

Clauses 1 to 4 inclusive agreed to.

On clause 5—Power to raise loan of \$500 million for public works and general purposes.

Mr. Macdonnell: I draw the attention of the committee to the fact that there is a change in the usual procedure. The usual form of the clause is that it has a second paragraph reading as follows:

All borrowing powers authorized-

By the section there set out.

—which are outstanding and unused shall expire on the date of the coming into force of this act.

I understand that the subclause has been left out because it is desirable that the outstanding borrowing powers, which I hope the minister will set out for us, should be retained, and I think the committee should be told what the total borrowing power still is.

Mr. Harris: Yes. When we passed the supplementary estimates we included in the appropriation bill provision for the borrowing of half a billion dollars. I believe that was on the 31st of March. The unused portion of that authority is now \$205 million, and that added to the present \$500 million that I hope will be voted will give us a borrowing power up to \$705 million for the time being.

Clause agreed to.

Clause 6 agreed to.

Schedules A, B and C agreed to.

Bill reported, read the third time and passed.
