RESERVATION OF LEGISLATION RESPECTING MINING CONTRACTS

On the orders of the day:

Hon. Lionel Chevrier (Laurier): Mr. Speaker, I should like to put a question to the Secretary of State or, in his absence, to the acting minister.

Is it true that the lieutenant-governor of Saskatchewan, Mr. Frank L. Bastedo, has reserved a bill on behalf of the crown concerning the right to renegotiate certain ore contracts with private corporations? (Text):

Right Hon. J. G. Diefenbaker (Prime Minister): Mr. Speaker, I think I might most appropriately answer that question. The first information the government received on this matter was on Saturday, when the lieutenant governor telephoned the under secretary of state that he had reserved a bill of the Saskatchewan legislature for the signification of the Governor General's pleasure. The bill, I am informed, purports to empower the

provincial government to alter mining contracts and is entitled the Mining Rights Alteration Act. We have no other information on the matter. There was no consultation in advance

in any way, and any action in this regard would be taken by the lieutenant governor himself.
