CANADIAN FLAG-REPORTED THREATS TO SUPPORTERS OF RED ENSIGN

Mr. Robert C. Coates (Cumberland): Mr. Speaker, on June 4 I posed a question to the Prime Minister with regard to threats which were made on the lives of Canadians who were supporters of the red ensign and of its retention as Canada's national flag. At that time the Prime Minister replied to me in a manner which I considered unsuitable from many points of view. One of the points of view which caused me a great deal of irritation was the flippant manner in which he treated the threats which were made on Canadians because they supported the red ensign.

In this connection I should like to refer to an article which appeared in the Toronto Daily Star, which said, among other things, that Richard O'Hagan, spokesman for the Prime Minister, said that the Prime Minister was joking. Well, Mr. Speaker, when the point is arrived at in this country where the lives of Canadians are threatened, and not only their lives but the lives of their families are threatened, and the Prime Minister treats this as a joke, then in my opinion the whole matter relating to a national flag has reached that sense of proportion that it should be removed from the public until the point is reached where a sense of proportion can Mr. Speaker: The hon. member for Burn- be given to the matter by the Prime Minister of this country.
