town with the main highway has been completely destroyed, has the Prime Minister received any request from the premier of that province for special disaster funds to aid in repairing the damage to this and other flooded areas in the province?

Right Hon. P. E. Trudeau (Prime Minister): I have not yet received such a request but I will check with my office to see whether any comes in.

FARM PRODUCTS MARKETING BILL—APPLICATION TO GROUPS OF PRODUCERS

In recognition of the serious concerns which are felt by most farmers' groups with respect to the implications of Bill C-176, is the minister in a position to assure us that no marketing agency for a specific agricultural product will be established unless it has been approved by the absolute majority of the producers involved?
