#### [Translation]

Hon. Jean Marchand (Minister of Regional Economic Expansion): Mr. Speaker, no more money is expended in Quebec than anywhere else. I think that we have spent some in Regina, through grants; we spent some in Sept-Iles, in Newfoundland, in New Brunswick—for the construction of a complex—in short we spend money everywhere. I do not think that more money is spent in Quebec than elsewhere.

## POLICY RESPECTING GRANTS—DISCUSSION WITH PROVINCES

Mr. John Burton (Regina East): A supplementary question. In view of some quarrel with the minister's statement, and in view of the widespread dissatisfaction with the department's programs as well as the fact the department is now reviewing designated regions and special areas, is the minister considering holding a conference with representatives of all the provinces in order to develop a more acceptable approach to the national problem of eliminating regional disparities.

Hon. Jean Marchand (Minister of Regional Economic Expansion): Mr. Speaker, we are in constant contact with the provinces and, as far as I know, no particular province has complained about our regional economic expansion programs. A few hon. members have complained but, apart from that, nobody has ever complained about the way in which we are proceeding.

**Mr. Burton:** A supplementary question. Will the minister consider making a statement on motions to explain why his department has made no progress in its job of eliminating regional disparities?

Mr. Speaker: Order, please. The hon. member will appreciate that this question is in the form of a statement or allegation and in those terms it is not acceptable.

Mr. Roch La Salle (Joliette): Mr. Speaker, I rise on a question of privilege.

I admit that there is much worry about the subsidies received by Quebec, but I deplore the fact that some hon. members are not happy to see that Quebec is getting some subsidies even when this is justified, and I would like to congratulate the Minister—

Mr. Speaker: Order. I suggest to the hon. member that there is no question of privilege there, but rather a question that could be debated.

Mr. James A. McGrath (St. John's East): A further supplementary. During that television interview the minister just referred to, he mentioned—

#### Some hon. Members: Order, order.

Mr. Speaker: Order, please. Would the hon. member ask the question?

Mr. McGrath: Mr. Speaker, it was the minister who referred to the television interview, and I can ask a supplementary question in the same vein. I should like to ask the minister if he could tell us who comprises the "outside committee", I think was the term he used, that he mentioned in the television interview yesterday? Who makes decisions under DREE? Could the minister name the members of that outside committee and could he tell us who has responsibility for the final decision?

Mr. Horner: And what role they play in the Liberal organization?

Mr. Marchand (Langelier): Mr. Speaker, no committee outside the department makes any decisions on subsidies. I simply stated that a committee made up of persons chosen outside the government supervised the application of the program and the allocation of subsidies. That is entirely different.
