**HISTORIC SITES****SUGGEST DECLARATION OF RESIDENCE OF RIGHT HON. L. S. ST. LAURENT IN QUEBEC CITY AS HISTORIC SITE**

**CRIMINAL CODE****SUGGESTED AMENDMENT CONCERNING FIRE PROTECTION IN ROOMING HOUSES—GOVERNMENT POSITION**

**Mr. Ron Atkey (St. Paul's):** Mr. Speaker, in the absence of the Minister of Justice may I put my question to his parliamentary secretary. In view of the fact that some 13 people have died in rooming house fires in Toronto in the last three months and serious concern has been expressed by municipal administrations over inadequate fire protection in private rooming houses in Vancouver, Winnipeg, Montreal, Toronto and other Canadian cities, and in view of the fact there was a unanimous request last week by the city of Toronto executive committee that the federal government amend the Criminal Code to make it an offence to maintain a multiple occupancy dwelling without proper fire protection and exits, would the minister indicate whether in any criminal legislation that is to come forward this session there is an amendment planned along these lines?
