Mr. Norman Kelly (Parliamentary Secretary to President of the Treasury Board): The government has received representations from Montreal-area organizations to relocate the Canadian International Development Agency and the Export Development Corporation from the National Capital Region to Montreal.

(a) The representations were made on various dates during 1981, by representatives of the Board of Trade and Chambre de Commerce of Montreal.

(b) Mr. Andy Haydon, Chairman of the Regional Municipality of Ottawa-Carleton has expressed concern about this proposal, which the government has taken under review.

(c) The government has, at this time, no intention to move either agency to Montreal.

2. Were any brought into Manitoba from other parts of Canada for the specific purpose of the election coverage and results and, if so (a) how many (b) who were they and what were their functions (c) from which locations and what were their transportation costs (d) what was the cost for food, lodging and other expenses while in Manitoba (e) what was the total cost of bringing these employees into Manitoba?

3. (a) What was the total cost to the CBC for computer services and staff for election results coverage (b) who was hired (c) how many computer operators and related staff were involved (d) what was the total cost for all of the computer related services?

4. What was the total cost of covering the election campaign and the results and what were the costs involved in reaching this figure?

Mr. Jack Masters (Parliamentary Secretary to Minister of Communications): I am informed by the Canadian Broadcasting Corporation as follows:

1. One hundred and fifty-fourth staff members took part at one time or another in actual election coverage work, i.e. coverage of the campaign and/or election night results, on behalf of four services—English television, English radio, French television and French radio—for local, provincial and national use.
