2. Can the Government assure the House that Canada's Sovereignty with respect to this territory and its boundary waters is not being exploited by a foreign Government or by any private citizens thereof?

*Mr. Church*—On Monday next—INQUIRY OF MINISTRY—1. Who represented Canada at the Washington Conference in 1922, and what other countries were represented?

2. Did Canada have representation there apart from Great Britain, and, if so, who were its delegates?

3. What stand did Canada take there, or elsewhere, as to the necessity of maintaining the Singapore base for naval security in the Pacific for Canada and the Empire?

4. Did Canada at that conference support the policy of dissolving our former alliance with Japan?

5. What was decided at the said Conference?

*Mr. Church*—On Monday next—INQUIRY OF MINISTRY—1. On what date were sanctions agreed to and put into effect by Canada against Italy because of Italy's invasion of Ethiopia?

2. When were sanctions withdrawn by Canada?

3. Will the text of (1) and (2) be laid on the Table of the House?

4. Has Canada approved or been asked to approve of the conquest of Ethiopia by Italy?

5. Has Italy or the Government of Great Britain asked Canada's approval?

6. Will all communications relating to questions four and five be laid on the Table of the House?

*Mr. Church*—On Monday next—INQUIRY OF MINISTRY—1. Was His Majesty's Government in Canada advised or consulted about the mission of Lord Halifax to Herr Hitler to find out what Herr Hitler wanted, and did Canada approve of the same, or was Canada asked to approve?

2. What were the results of the said visit?

3. Will any communications, if any, from the Government of Great Britain, be laid on the Table of the House, or have any been received?

4. Did Lord Halifax at these interviews have power to represent Canada?
