From these considerations your committee is convinced that they have only to thank God and take courage-to lift up the voice of thanksgiving, and the hand of prayer, and whatever is found to do, do it with all their might, for they are well assured that they are not beating the air while they are circulating that word which shall stand forever. The promises contained in that book which you disseminate is sufficient to encourage the most desponding, to sustain the feeblest arm, and to animate the strongest courage.
