

Shippers Decide to Pay More for Potatoes

Ready to Give Farmers Bigger Price for Their Potatoes.

THE UPPER CANADA DEMAND LARGE

Heavy Snow Storm and Cold Weather Demoralize Train Service in Carleton Co.—Business Suffers

Hardland, N. B., Feb. 16.—The excessive cold of the past week has overhauled all records for many years in this section of the country. The thermometer has dropped as low as 36 below the zero, and the effect has been to bring business almost to a standstill, especially from outside points. Men who have come in from the woods report much suffering from the cold in some of the camps. The snow has drifted along the roads to such an extent that travelling is not only difficult but hazardous.

The storm of Saturday was the worst for a long time, and has not only crippled travel by teams, but the train service has been badly demoralized. Where usually there are from eight to a dozen trains either way going through here, for the past two or three days there has been practically none but those carrying passengers and mail, and these have been way off their schedule.

Memorial Service.
On Sunday evening in the Reformed Baptist church the Rev. C. T. held a memorial service for the founder of the order, Miss Francis Willard, Rev. P. A. HARD FIGHT FOR LIFE IN SNOWSTORM

Madawaska Family have Trying Experience—Horse Lost Road in Blizzard—Log Cabin Refuge.

Madawaska, Me., Feb. 17.—Gaspard Violette, his wife and four children, who live in the New Brunswick side of the line, a short distance from here, all but lost their lives in the blizzard Saturday night. Their horse lost the road in the darkness a few miles from their home, and went into the deep snow, almost out of sight. He then commenced kicking and smashing the thills and harness. All of the children are under 12 years of age and the plight of the family was a desperate one.

Looming up out of the darkness in the edge of the woods at the side of the road, only a few rods distant from where the accident happened, Mr. Violette spied the shadowy outline of a log cabin. He succeeded in making his way to it through the drifts and found that it contained a dilapidated stove and some fire wood. He managed to bring his wife and children through the drifts from the sled and, after repeated failures, succeeded in starting a tiny blaze. By this time all were benumbed with the cold.

Twice the fire went out but, at length, Violette managed to build a fire which would burn and soon the stove was red hot. Bringing blankets from the sled, he spread them out for the children. But Mr. and Mrs. Violette, fearing that the fire would go out, remained awake all night.

Violette succeeded, later, in freeing his horse from the tangle of leather straps and led the animal into one corner of the camp.

On Sunday they managed to make their home unaided. Their hands and feet were badly frostbitten from the experience, but it is expected that no permanent ill effects will result.

The storm was one of the worst ever known in northern Maine and on the St. John and Amherstook railroads had been practically at a standstill. The snow has drifted badly and on Monday it was blowing back as fast as it could be cleared from the tracks with snow plows.

SYNOPSIS OF CANADIAN NORTH-WEST LAND REGULATIONS.

COAL.—Coal mining rights may be leased for twenty-one years, renewable at an annual rental of \$1 an acre. Not more than 2,500 acres can be leased to one applicant. Royalty, five cents per ton in unmineralized territory the tract must be staked out by the applicant in person, and personal application to the Agent or Sub-Agent of Dominion Lands for the district, must in all cases be made and the rental for the first year must be paid to the agent within thirty days after the date of the lease.

QUARTZ.—A person eighteen years of age and over, having made a discovery may locate a claim 1,500 feet by 1,000 feet. At least \$100 must be expended on the claim each year, or paid to the Mining Recorder. When \$500.00 has been expended or paid and other requirements complied with the claim may be purchased at an acre.

PLACER MINING CLAIMS are 500 feet long and from 1,000 to 2,000 feet wide. Entry fee, \$10.00. Not more than \$100 must be expended in development work each year.
