ander Anderson-Participation of New York Soldier in Recent "Horror On Rhine" Meeting Pronounced As Detrimental to Relations Between Allied Nations and United States.

New York, March 23 .- Alexander E. Anderson, formerly lieutenantcolonel of the 165th Infantry, was notified today by the New York county legislative committee of the American Legion that he had been expelled from the United States Veterans' Association because of his utterances at the recent "orror on the Rhine" meeting here. This meeting was called as a protest against the alleged use by the French of negro troops in the occupied zone of Germany, and later was condemned by legionaires as "propaganda to destroy the cordial relations existing between the United States and her war allies."

Committee Unanimous.

An immense meeting was held at Madison Square Garden last Friday night under the auspices of the legion to protest against the previous pro-German meeting. General, Pershing in a strong speech scored kaose who were attempting to spread propaganda in the United States for the purpose of creating ill-will against Great Britain and France. The legion committee voted unanimously for the expulsion of the former officer last midnight after a trial that had lasted more than six hours. His participation in the meeting was declared to be prejudicial to the best interests of the legion. Anderson did not attend the trial. but had sent a letter claiming the committee lacked -jurisdiction, in that the 69th Regiment Post, of which he was the former commander, ceased to exist last December.

Anderson's case is said to be the first instance in which a member of the American Legion has been tried and expelled.


