Mr. Lang, seconded by Mrs. Sauvé, moved,—That the Bill be now read a second time and referred to the Standing Committee on Justice and Legal Affairs.

After debate thereon, the question being put on the motion, it was agreed to.

Accordingly, the Bill was read the second time and referred to the Standing Committee on Justice and Legal Affairs.

The House resumed the adjourned debate on the motion of Mrs. Sauvé, seconded by Mr. Lang,—That Bill C-25, An Act to protect human health and the environment from substances that contaminate the environment, be now read a second time and referred to the Standing Committee on Fisheries and Forestry.

And debate continuing;

Mr. Fraser having proposed to move,—That all the words after "That" be deleted and the following substituted therefor:

Bill C-25 be not now read a second time but that the subject-matter thereof, the protection of human health and the environment from the release of substances that contaminate the environment, be referred to the Standing Committee on Fisheries and Forestry in order to consider a more appropriate legislative mechanism to establish mandatory procedures whereby substances be reported to the Minister of Health and Welfare and the Minister of the Environment prior to manufacture or sale.

And a point of order having been raised as to the acceptability of the proposed amendment, Mr. Speaker deferred his decision.

Debate was resumed on the motion of Mrs. Sauvé, seconded by Mr. Lang,—That Bill C-25, An Act to protect human health and the environment from substances that contaminate the environment, be now read a second time and referred to the Standing Committee on Fisheries and Forestry.

And debate continuing;

A Message was received from the Senate informing this House that the Senate had passed Bill C-214, An Act to amend the Electoral Boundaries Readjustment Act, without amendment.
