

*Proposed Legislation*APPLICATION OF COLLECTIVE BARGAINING TO
CROWN AND EMPLOYEES

Mr. Frank Howard (Skeena) moved for leave to introduce Bill No. C-14, to amend the Industrial Relations and Disputes Investigation Act (application to civil service).

Some hon. Members: Explain.

Mr. Howard: Mr. Speaker, the bill seeks to bring the crown and employees of the crown, usually referred to as civil servants, within the provisions of the Industrial Relations and Disputes Investigation Act except in respect of those provisions relating to strikes and walk-outs, and also the further provision that the House of Commons will retain its traditional jurisdiction over money supply. The intention is to so arrange matters that conciliation board reports will be placed before the house in time for budgetary arrangements to be made.
