CANADIAN FORCES SUPER-ANNUATION ACT

SUGGESTED EMPLOYMENT OF PENSION RE-CIPIENTS IN PUBLIC SERVICE WITHOUT BENEFIT LOSS

Mr. D. W. Groos (Victoria (B.C.)) moved:

That, in the opinion of this house, the government should consider the advisability of amending the Canadian Forces Superannuation Act so as to permit all persons who are in receipt of pensions under the provisions of the said act to enter into employment in any branch of the public service of Canada without suffering loss of pension benefits.

He said: Mr. Speaker, the subject matter of my notice of motion is partly under consideration as a result of government Bill No. C-193. In accordance with the rules of this house I should withdraw my motion and I shall do so, but before I do I hope you will permit me to make a few remarks about the Canadian Forces Superannuation Act and pensions generally.

It is being proposed that two sections of the act be deleted which have been working against retired servicemen who wish to work for the government in not permitting them to draw full pension as well as full pay. As I understand the situation, a section will be substituted which will permit the Governor in Council acting by regulation to consider various cases. At the present time the act states that warrant officers second class and above or their equivalent ranks and chief petty officers second class and above may work for the government but their pay and pension combined must not exceed the present level of pay for the rank they held on retirement.

Mr. Chatterton: Mr. Speaker, I rise on a point of order. Did I understand the hon. member for Victoria, B.C., to say that he is asking for leave of the house to withdraw his motion? If that is so I should like to raise the question of the hon. member being allowed to speak now.

Mr. Speaker: My understanding is that the hon. member has made a motion and that motion is now before the house. He has indicated that eventually he will ask leave of the house to withdraw it and at that point he will require the unanimous consent of the house. At the moment he is speaking on the motion itself, as I understand it.
