## INQUIRY OF THE MINISTRY

Mr. Colin Cameron (Nanaimo-Cowichan-The Islands): Mr. Speaker, may I direct a question to the Secretary of State. It arises out of a report on the C.B.C. screen yesterday of a sale that took place at Christie's, the famous art and antique sales market in London, of a chart drawn by Captain James Cook of the St. Lawrence river, including the area adjacent to Quebec, a chart actually used by General Wolfe in the assault on Quebec. Surprise was expressed in London that there had been no attempt on the part of the Canadian government or any Canadian body to seize the opportunity to obtain this historic chart. My question is this: Did the Canadian High Commissioner in London inform the government of this opportunity to acquire in centennial year a priceless piece of Canadiana for the National Archives? I might add that the bidding did not reach the owner's reserve price.

PRINCE EDWARD ISLAND CAUSEWAY-REDESIGNING AND RESCHEDULING OF CONSTRUCTION
