HOGS-ALLEGED DISSATISFACTION WITH QUALITY PREMIUMS

Mr. George Muir (Lisgar): Mr. Speaker, I have a question for the Minister of Agriculture. I have been wanting to ask the minister this question for a number of days, but because of the roster system I have not been able to do so. In view of the widespread dissatisfaction with the new quality premium being paid on hogs, was there any discussion between the federal government and the Canadian Swine Council before the recently announced alterations in policy on hog quality premiums were made?

was in the house yesterday and he could have asked the question then. I would also like to advise him there was a great deal of discussion with the Canadian Swine Council and other people who were interested in the new grading system for hogs. Obviously the government has to assume the responsibility for the amount and level of subsidies paid on hogs or for any other purpose. While there was consultation with regard to changing the incentives paid through the marketplace respecting hogs, and this grading system, we have to accept the responsibility for the level paid out of the treasury.

Mr. Muir (Lisgar): A supplementary question, Mr. Speaker. I have a statement from the Canadian Swine Council which states they never had any discussions-
