Mr. Stackhouse: In view of the difficulties that firms in the construction industry are having regarding the escalation of costs between the time of tendering and the time of fulfilling contracts, would the minister indicate whether the construction industry is an industry in which he thinks the profits are so healthy that businesses can absorb increases in costs?

SEALS—ALLEGED LANDING OF HELICOPTERS CARRYING AMERICAN TOURISTS IN MIDDLE OF HERDS—REQUEST FOR RESCINDING OF REGULATIONS GOVERNING HUNT

Mr. Walter C. Carter (St. John's West): Mr. Speaker, my question is directed to the Minister of Fisheries. Is the minister aware of the fact that helicopters carrying American tourists are landing in the middle of seal herds, thereby causing panic among the herds and danger to the landsmen hunting the seals? If not, would he ask his colleague the Solicitor General to direct the RCMP to investigate this matter and to take the necessary action, since this contravenes a section of the Fisheries Act?

Hon. Jack Davis (Minister of Fisheries): Mr. Speaker, allegations to that effect have been made and we are making investigations.

Mr. Carter: In view of the fact that the regulations imposed on the seal fishery by the minister were passed largely on the recommendation made to him and the government by one Brian Davies, the person now responsible for breaking the law, and in view of the fact the regulations have had a very serious effect on the economy in certain parts of eastern Canada, would the minister now undertake to have these regulations rescinded, thereby restoring the sealing industry to eastern Canada?
