RECOGNITION OF WOMEN'S RIGHTS—PETITION TO SASKATCHEWAN PREMIER—MOTION UNDER S.O. 43

Mrs. Ursula Appolloni (York South-Weston): Madam Speaker, I rise under the provisions of Standing Order 43 on a matter that has perhaps never been more urgent in the life of this nation. In this morning's edition of *The Globe and Mail*, it was reported that the Premier of Saskatchewan was preventing Canadian women from having full equality of rights which would be guaranteed in the Canadian Charter of Rights.

Madam Speaker, I move, seconded by the hon. member for Trinity (Miss Nicholson):

That this House calls upon the hon. member for New Westminster-Coquitlam and the hon. member for Vancouver East, as well as the following NDP members from Saskatchewan; the hon. member for The Battlefords-Meadow Lake, the hon. member for Humboldt-Lake Centre, the hon. member for Prince Albert, the hon. member for Regina East, the hon. member for Regina West, the hon. member for Saskatoon East, and the hon. member for Yorkton-Melville, to petition their fellow New Democrat, the Premier of Saskatchewan, to change his current position so that provisions to ensure guaranteed rights for women will be included in the resolution now before Parliament.

Miss Pauline Jewett (New Westminster-Coquitlam): Madam Speaker, the reason British Columbia and Alberta came around was because people like me named them.

Mr. Svend J. Robinson (Burnaby): Madam Speaker, I certainly support the intent of the motion. I would like to move an amendment to the motion that we further call upon all premiers to restore Section 34, granting aboriginal rights, to the constitutional resolution.
