**PRIVILEGES AND ELECTIONS****CONCURRENCE IN 26TH REPORT OF STANDING COMMITTEE**

**Mr. Peter Milliken (Kingston and the Islands):** Madam Speaker, I move:

That the 26th report of the Standing Committee on Privileges and Elections presented to the House on Wednesday, March 20, 1991 be concurred in.

He said: Madam Speaker, I just want to summarize the report.

The Standing Committee on Privileges and Elections received a request from the hon. member for Perth—Wellington—Waterloo to amend the Standing Orders to permit joint sittings of standing committees so that two

or more committees could meet together, have a joint meeting, hear witnesses and prepare a transcript of the proceedings.

The purpose of the amendment to the Standing Order that the committee has recommended in the 26th report is to do exactly that. It simply adds the words necessary to effect the change requested by the hon. member for Perth—Wellington—Waterloo.

The committee is of the opinion that this will enhance the ability of committees of this House to function effectively.

I am moving this today in light of the fact that we are in the midst of changes to the Standing Orders. This could be printed with the reprinting that will take place as a result of the division last evening.

I note that the report was agreed to by all members representing all parties on the standing committee.

**Mr. Harvey (Edmonton East):** Madam Speaker, I just note that our caucus too is in full agreement with the motion of concurrence.

**Mr. Cooper:** Madam Speaker, the Standing Committee on Privileges and Elections must truly be on a role.

It had the 21st report which was part of the reform package that was adopted unanimously last night. Because of our interest and encouragement of the committee system in this Parliament, we on the government side are happy to give our support and endorsement to this particular amendment. We urge the adoption of this amendment unanimously.
