Mr. Dennis Mills (Broadview—Greenwood): Madam Speaker, I appreciate having the opportunity to rise and speak on this motion in the House today. I would like to begin by going back to the beginning of the debate on Wednesday when the hon. government House leader rose and presented his motion. As I was listening to him, in the initial part of his speech I was moved by his words and I thought that this was going to be a pretty productive debate.

We hear from our own families and friends that we did not need to pay Mr. Spicer \$27 million to hear that people across Canada, generally speaking, are absolutely frustrated and incensed at the way we sometimes behave in this House in terms of our actions and the insults we hurl at one another.

I sat there listening to the government House leader and all of a sudden, lo and behold, an incident came up and I lost it. I sort of blurted out something at the government House leader which I certainly was not pleased with. I reflected later in the day on why it is that we seem constantly to get into this use of language and finger pointing at one another to such an extent that we behave in front of national audiences in a way that we certainly would not behave if we were in a corporate boardroom, if we were in a classroom, if we were at a
