Nevada Startled

By the Murder of U. S. District Attorney Jones.

Shot Dead by a Boy of 16, Who Thought His Father's Life Was Threatened.

Carson, Nevada, Nov. 10 .- The entire state was startled at the murder late yesterday of Charles A. Jones, United States district attorney, by Julian Guinan, the 16-year-old son of a wellknown local physician.

The statement of the youth, who is now in jail, is to the effect that immediately prior to the shooting he had bserved his sister talking to Jones, with whom his father had forbidden association. When he saw Dr. Guinan approaching, believing trouble to be inevitable when the two men should meet, the boy procured a Winchester rifle and stationed himself at a window for the purpose, as he says, of protecting his father. Upon encountering Jones, Dr. Guinan said: "This is the last time I shall ever warn you against keeping company with my daughter." Jones jeered at the doctor in comment upon his warning, and slipped his hand into his right-hand often heard his father threaten to kill Jones, and having been informed that the district attorney always carried a revolver, which he believed from Jones' motion was about to be drawn, the ward dead, the bullet from the rifle having entered above the right eye and passed out of the neck behind. Miss Guinan, seeing Jones fall, threw herself upon him and embraced the dead body.

The shooting, which took place in the street in front of the Hotel Albion, was witnessed by the mother and sister of the principals, and also by Albert Woods and Lewis Dumart; the latter has gone out of town. All parties interested in

the affair are very reticent. The latest story is that Harvey Elliott, Albert Woods and L. Dumart, of Bayfield, spent the afternoon at Varna, arriving back at Elliott's hoteabout 9:30 p.m. All were slightly intoxicated. About 10 o'clock Wood and To Jane Kent, wife of Thomas Kent. Dumart went to a store and got biscuits and cheese for a lunch. On re-turning they found Fred and Harvey outside of the hotel. Woods and Mrs. Elliott tried to separate them, when Fred drew a revolver and fired at his


