War's grim realities have already touched very closely some of the homes of London, where relatives wait and wonder for news of their loved ones. Last week, Thomas Whitney, 111 Adelaide street, received a cablegram stating that his brother was a survivor of the formidable wreck, and was lying in a hospital in old London, seriously injured. The news was conveyed to two sisters, also living here, Mrs. Brabrook, 18 Landon street, and Mrs. Cagan, 123 Adelaide street. Since then, they have anxiously awaited further information, none of which has reached here to date.

Three Sons Serving.
In England is a widowed mother, in order to be a comfort to her at the Christmas season, Ernest Whitney, formerly in Victoria Hospital, went home in December. Another brother, after eight years in India with an Irish regiment, had just arrived in England for a holiday, when he was ordered to the front in France. A communication received from him was written in Winchester, December 22, and relatives surprised to find it with the words "I am a soldier." Still another brother of six in all is serving his country in this war.

"We think our mother will let us know how our sailor brother is as soon as she can. All we can do is to keep on hoping for the best," said Mrs. Cagan, this morning, voicing the feelings of the members of the family who are here. Awarded \$2,500 Through Fatality Due to Electric Light Pole Breaking.

Mrs. Jane Christie, widow of John C. Christie, was awarded \$2,500 damages from the London Electric Company this afternoon in her action that was tried at the winter sessions of the supreme court before Mr. Justice Brien. The jury held that the company was liable, and that the pole inspector of the company was to blame for allowing a rotten pole to stand as long as it did. John C. Christie was killed on July 23, 1914, when, in the employ of the Electric Company, he was sent up one of its old poles to strip the wires. When half way up the pole, he heard it crack, and as it broke, he attempted to jump from it to the new pole a few feet away, missed it, and fell to the ground. He was instantly killed. Sir George and George S. Gibbons acted for the plaintiff and Meredith & Meredith for the defence.

The action of Christopher Erb against the Grand Trunk was settled out of court. Erb claimed \$5,000 damages for having a leg broken in a runaway accident, alleged to have been caused by the escaping steam from an engine.

**SOLDIERS' WIVES ARE
LIVING IN COMFORT**

Patriotic Fund Payments Amounted to Over \$1,000 in Week.

Since the recruiting for the Third Contingent started, there has been a rush to the London and Middlesex Patriotic Relief Fund Association of soldiers' wives for the Patriotic Fund allowance.

More than 250 soldiers' wives and mothers, whose supporters are in the First and Second Contingents, are now receiving weekly aid from the association. Last week, over \$1,000 was paid out in relief money.

Many soldiers' wives who before the husband enlisted were in extreme poverty are now living in comfort from the Government allowance of \$20 per month, the money being sent to the Patriotic Fund, which is sometimes as much as \$20 per month, and the money which the husband sends home from Salisbury.

Before any money is paid from the Association to applicants for aid, the case is thoroughly investigated. In cases of extreme stress, groceries and provisions are ordered to be sent to the home from the nearest stores.
