The Sugar and Wool Schedules to Be... Re-visited, the House Expects...

WASHINGTON, June 19.—The Senate... today added a new paragraph to the Tariff bill...

The sugar schedule, as it will finally... be adopted, will provide for a duty of 40 per cent...

The discriminating duty of 1-10th of a... cent against all countries paying an export...

bounty on refined sugars will be eliminated... from the bill, as it is claimed that the 40...

per cent gives ample protection to the... refiners, to say nothing of the differential...

that is involved there. The sugar schedule... will also be further amended so as to make...

it go into effect when the other parts of... the bill go into effect—immediately upon its...

passage.

The wool schedule to be changed.

Another change will also be made in the... wool schedule. As agreed to, the rate on...

the finished product in men's clothing is... now fixed at 45 per cent, while the duty on...

raw wool entering into the manufacture of... the same grade of goods is fixed at 50 per cent...

This is a discrimination against the... manufacturer in this country that will be remedied...

by increasing the duty on the finished... product to 40 per cent.
