SALVAGE OF TUG "EMERALD STRAITS"-FORMAL INQUIRY UNDER ACT

Mr. Harold E. Winch (Vancouver East): Mr. Speaker, on Monday and Tuesday of this week I and others directed questions to the Minister of Transport about a matter of concern to the Pacific coast. It had to do with a certain type of tug, its sinking, and death. I understand the minister promised to reply today. If he is now prepared to reply may I ask him to make the comments that he promised to make on this matter.

Hon. Donald C. Jamieson (Minister of Transport): Mr. Speaker, immediately after the sinking of the tug Emerald Straits a preliminary inquiry was undertaken. As a result of the work of the inquiry photographs and observations were taken at the site of the wreck. The vessel was located. No structural damage was found. However it is now felt that there ought to be a formal inquiry under the Canada Shipping Act.

It is my view that the inquiry can only succeed if the vessel is brought to the surface to be examined thoroughly. Consequently, tenders to recover the tug will be called within the next few days and the formal inquiry will have the opportunity to get under way very shortly.
