#### ASSISTANCE TO MUNICIPALITIES TO CLEAN UP SEWAGE PROBLEMS

**Mr. Randolph Harding (Kootenay West):** Mr. Speaker, in view of President Nixon's proposal for a new federal-municipal financing arrangement that in five years will provide every community which needs it with secondary waste treatment, and also special additional treatment in areas of special needs, including communities on the Great Lakes, I should like to ask the Minister of Finance whether the federal government will match this proposal with a real drive to assist all Canadian municipalities to clean up their sewage problems in five years, with special assistance to those Canadian areas where special need is indicated, such as the Great Lakes system?

**Mr. Speaker:** Order, please. I should like to suggest to the hon. member that, while the minister obviously wants to reply, the hon. member is inviting the minister to make a statement which to my way of thinking would be of a rather general nature and ought to be made on motions.

**Mr. Harding:** Mr. Speaker, on a question of privilege, might I ask the minister if he would make a statement on motions and when?

**Hon. E. J. Benson (Minister of Finance):** I would very much like to look at the statement of Mr. Nixon which I have not seen to date. The federal government has been assisting with sewage disposal for municipalities for I believe about eight years now, so we are probably about eight years ahead of the United States.

#### WHITE PAPER ON REFORM—CONFLICTING ESTIMATES OF INCREASED REVENUES

**Hon. Robert L. Stanfield (Leader of the Opposition):** Mr. Speaker, I should like to ask the Minister of Finance, in light of the statement reported last evening and attributed to the Prime Minister of Ontario, which reaffirmed Ontario's calculation of \$1.3 billion as the figure of increased revenue represented by the white paper, whether the minister has altered his calculation or can he report any progress to the House with regard to reaching a consensus on the matter?

**Hon. E. J. Benson (Minister of Finance):** Mr. Speaker, as I reported to the House, from a cursory glance at the Ontario figures I found an error of \$200 million. We offered to meet with the provincial officials immediately and they asked for a postponement of ten days to check their figures.
