## THE AUDITOR GENERAL

INQUIRY AS TO LEGISLATION TO IMPROVE EFFICIENCY

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I should like to direct a question to the President of the Treasury Board. In view of the indication in the report of the Auditor General that all is not yet perfect in the area of government expenditures, can the President of the Treasury Board tell us when the government will be introducing the legislation the Auditor General has been seeking to better define and enable him to carry out his position, duties and responsibilities? Can the President of the Treasury Board give the House the time when this legislation will be introduced?

Hon. C. M. Drury (President of the Treasury Board): Mr. Speaker, I do not think I can give a time. I recognize that there are certain things wrong with the present legislative arrangements in respect of the Auditor General, and to this end studies have been conducted looking toward new legislation. I have not been able to get a satisfactory time as yet from the House Leader so I would hesitate to give any undertaking.

Mr. Stanfield: I have a supplementary question, Mr. Speaker. It is apparently not only the existing legislation that is not entirely satisfactory. Does the President of the Treasury Board intend to take any steps to ensure that the arrangements in respect of staff for the Auditor General are more satisfactory to the Auditor General so that as an officer of this House he will not be dependent upon the overriding decisions of the minister and so that he will have the staff that he thinks he requires in order to do the job of investigation which obviously, as can be seen from his report, is required?

Mr. Drury: Mr. Speaker, I might point out in this connection that the authorized establishment of the Auditor General has never up until the present been filled. The numbers authorized have always exceeded the strength. This continues to be the case. If the
