DELIVERY OF GRAIN—MOTION UNDER S.O. 43

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, I, too, have a motion which I am sure is supported by the Minister of Transport (Mr. Mazankowski). It arises from the fact that the chief commissioner of the Canadian Wheat Board has said the federal government's projected 20 per cent increase in grain movement this year will not be met because the transportation system can only handle an extra 10 per cent. Since this 10 per cent increase means no more grain will move this year than moved two years ago under the Liberal government, I move, seconded by the hon. member for Win-
