Mr. Turner (Vancouver Quadra): They want to go to a sympathetic Member.

Ms. Mitchell: That's right. They know where to go and—

Mr. Speaker: Order, please.

Ms. Mitchell: I must say that there have been a great number of petitions from that riding.

Mr. Speaker: I would ask the Hon. Member to do her petitions without comment.

Ms. Mitchell: Mr. Speaker, I have another petition from the Province of Quebec which is also opposing the Government policy to reduce the indexation of family allowance and asking for full indexation. Another petition is from Fort Erie and surrounding communities in Ontario and the petitioners are asking for the same thing.
