follow the same course so that our committee work can be pursued without interrupting our proceedings here.

Hon. Jacques Flynn: Honourable senators, I merely rise at this time to ask the Leader of the Government what he said concerning Bill S-20, an act to amend the Copyright Act. I think he mentioned that he hoped the debate on this bill could be concluded next week and that the bill would be referred to committee, which suggests to me that the Government is going on with this bill. If so, I suggest that is contrary to what had been indicated by the sponsor of the bill. It appeared to me the last time we discussed this bill that an agreement had been reached between the Government and some of the interested parties that this bill would not be proceeded with. Has there been some new development?

Hon. Mr. Martin: No. I think the Leader of the Opposition has correctly stated the situation. In the light of discussions that were under way, I did not feel that it would be desirable at this time to emphasize that fact. Your interpretation of the situation is correct; I do not believe we will proceed with the bill.

Hon. Mr. Urquhart: Honourable senators, may I add to what the Government Leader has said? It is not the intention of the Government to proceed with the bill, but the bill will stay on the Order Paper until a certain undertaking has been received from the record manufacturers, which they promised to give this week to the Minister of Consumer Affairs.
