Not content with shutting out the produce of Canadian farms, there is now, a loud wail against allowing the lobster catch on our Coasts, into the United States. The farmers of the U.S. made sufficient noise for a high tariff, to keep out Canadian farm produce, and the fishermen of the U.. The Canadian open season for lobster fishing began on Nov. 1 and 15 and our markets are flooded with the inferior grade of lobsters because new shell lobsters will not stand up to ship so far. The dead and weak ones are boiled and put on the market. at a very low price and this has a tendency to reduce the price of the native stock considerably.


