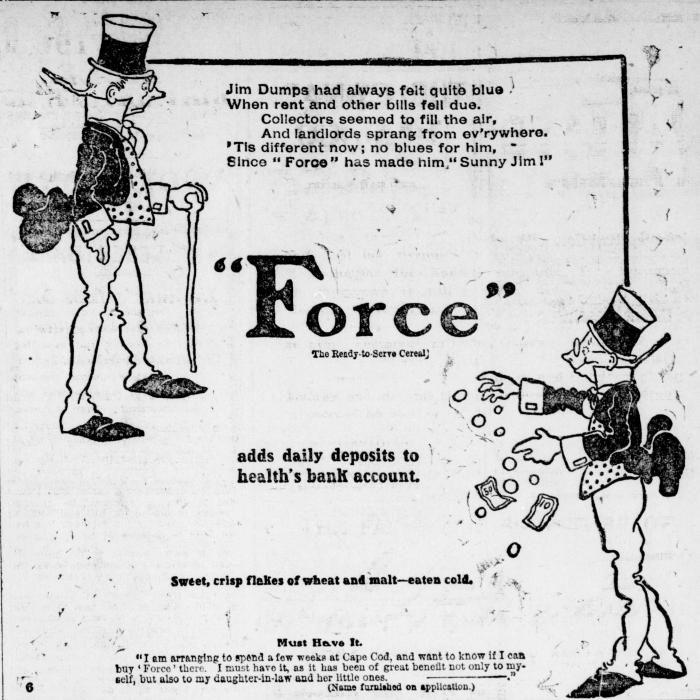

# BRANTFORD FIRMS ARE BURNED OUT

Worst Fire the City Has Had for Years.

THREE FIREMEN WERE INJURED

Fire Blazing at 1 O'Clock This Morning-One Firm's Loss Placed at \$70.000.

Brantford, Ont., Sept. 18.-Tonight Brantford experienced one of the worst fires it has had for many years. At 9:30 fire was discovered coming out of the third story windows in the brick building of the Snowdrift Company on Dalhousie street. The firemen responded promptly and put eight streams of water on, but the fire had too great headway before it was noticed. They no sooner sub-dued one place than it burst out in another, sometimes in the cellar and again in the third story. They could make no headway with it and an hour's hard fighting it burst through the roof.

Soon after this smoke was seen com-ing through the roof of the adjoining brick building of George Watts & Sons' wholesale store, corner of Dalhousie and King streets. It was not many minutes before there was a crash from the top of George Watts & Sons store, the roof fell in and the front of the third story fell out across the street, causing a stampede among the spectators.

FIREMEN HURT. With this wall falling out three firemen were more or less severely in-

Brantford, Sept. 19 .- At 1 a.m. the fire is still raging, but under control. R. M. Fullerton, proprietor of the Snowdrift Company, owns the building. The loss will be in the neighborhood of \$30,000. He carries an insurance of \$10,000 on the building and \$5,-000 on the stock, which is a complete loss.

Geo. Watts & Sons, wholesale grocers, own their place. The loss or insurance are not known. Roughly estimated it will be about \$70,000. The building and stock are a complete loss. When the walls fell it took telephone and electric light wires down, and the city is in darkness, the power being shut off.

ROCKFELLER HOUSE BURNED. Tarrytown, N. Y., Sept. 17 .- John D. Rockefeller's country seat at Pocantico Hills, was destroyed by fire tonight. The fire started in the housekeeper's apartments on the ground floor, and within two hours the walls of the building had fallen. Mr. Rockfeller was not there. It is said that he is in

Iowa. The explosion of an oil lamp is said to have started the fire. The house was situated on a hill about 500 feet high, and the fire department was practically powerless, as owing to the altitude, it was impossible to get any

adequate water pressure.

Mr. Rockfeller bought the house about six years ago from Judge Wentworth, of New York. The house was plainly furnished. No one here tonight is able to give an estimate of the damage. The building itself was worth about \$20,000.
