Hon. Mr. MACLEAN:

4. The department was able to obtain the services of a sufficient number of trained men to man H.M.C. ships then in the Canadian Naval Service without availing itself of the offers of these gentlemen.

ONTARIO AND QUEBEC COLONIZATION. Mr. DESLAURIERS:

1. Is it the intention of the Government, during the present period of reconstruction, to promote colonization in those parts of Northern Ontario and Quebec through which the Transcontinental Railway is extended?

2. In this connection, could not the colonists or settlers be given travelling rates at one cent per mile, or even free transportation in the case of delegates who organize groups of intending

settlers from the older districts of Canada?
3. Could not the Government also arrange to have settlers' effects, farm and forest products transported at such a reasonable rate as would stimulate production and clearance of land?

Hon. Mr. CALDER:

1. The Government will co-operate in every way possible with the Provincial Governments concerned to secure the end referred to.

2 and 3. These questions involve matters of policy worthy of consideration. Any decision reached would have to be made applicable to all parts of Canada. The matter will receive early attention.
