House. Every question is determined in a committee in the same manner as in the House to which it belongs.

This means that every matter is decided by the committee and not by the House or by the Prime Minister. I think that the Prime Minister, by expressing his opinion in the House on the way the committee should conduct its business, is breaching the privileges of the committees of this House.

I merely indicated that those terms of reference existed, that we did not see any reason to change them for the time being, and that we were hoping that they would be construed in the spirit in which we had given them.
