would be the cheapest although that would require some looping of the existing line. It does not rule out, however, the possibility that a northern tier line, if you like, might be added as an additional facility to western Canada.

Mr. Broadbent: Mr. Speaker, I rise on a point of order. About 17 minutes ago you indicated that you would recognize me for a supplementary on the important question of housing, and since it is almost six o'clock and it is an important matter I wonder whether that could be done?

Mr. Speaker: My understanding is that the question which the hon member was going to ask was so important, along with others, that members would want to conclude the question period before we rise,—there are some 13 minutes or so left—otherwise we would have to continue the question period at eight o'clock. I am in the hands of the House in this regard.

Some hon. Members: Agreed.

# WELFARE

REQUEST FOR INCREASE IN FEDERAL AID TO PROVINCES UNDER CANADA ASSISTANCE PLAN

Mrs. Grace MacInnis (Vancouver Kingsway): Mr. Speaker, my question is directed to the Prime Minister. In view of the fact that families on low income with children are suffering especially from the high food prices, and in view of the fact that my leader pointed out earlier that some of the provinces cannot afford this cost-shared assistance, will the government now offer, under the Canada Assistance Plan, to pay the full cost of increased provincial or municipal food allowances to families on social assistance.

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I do not agree with the premise of the hon. lady's leader that no province can afford this. It really depends where they put their priorities.

Mr. Trudeau: But, Mr. Speaker, the fact is that the government has acted to help all families with children by announcing legislation to effect an immediate increase to \$12 of the payments under the present Family Allowances Act, lest some provinces not want to act along the Canada Assistance Plan lines that I suggested.
