- 3. The Government and every member of the Regular Force contribute under the Canadian Forces Superannuation Act.
- 4. No. The Government contributes 1.8 times the members' contributions and, in addition, credits the account with interest and also assumes the responsibility for actuarial deficits as well as the amount considered necessary to provide for the increase in cost of benefits due to pay increases.

### SOY BEAN MEAL

Question No. 19-Mr. Horner:

How much soy bean meal was used for human consumption in (a) 1973 (b) 1974 to date?

Hon. Otto E. Lang (Minister of Justice): Soy bean meal is not used for human consumption but is used in livestock and poultry feeds. Soy bean meal can be further processed into isolates and protein concentrates which are used in human nutrition. There are no statistics available for human utilization in Canada but it is estimated that approximately 0.3% of Canadian production of soy beans is used in human nutrition in Canada, or approximately 25,200 cwt.

The financial contribution to NATO infrastructure and military budgets for the period 1970 to 1973 was as follows: 1970/71, \$14,384,000; 1971/72, \$13,834,000; 1972/73, \$14,323,000; 1973/74, \$21,000,000 (estimated) See Note: 1.

- 2. The number of Canadian Forces personnel placed at the disposal of NATO for the years indicated is as follows:

Note: 1. The significantly higher contribution to NATO in 1973/74 was due to approximately \$3,000,000 having been outstanding for 1972/73. This was caused by a new NATO policy of programming construction costs over a shorter time frame. Thus the contribution to NATO for the two fiscal years averaged: 1972/73, Approx. \$17 million; 1973/74, Approx. \$18 million.
