# BANKS AND BANKING

CANADIAN COMMERCIAL BANK—NON ATTENDANCE OF MINISTERS AT MARCH MEETING

Hon. Barbara McDougall (Minister of State (Finance)): Mr. Speaker, it is very clear that the G-Five meeting is a normal, routine meeting that takes place before the IMF meetings in the fall. Surely the Hon. Member is that well informed.

Some Hon. Members: Oh, oh!

Mrs. McDougall: The Minister of Finance has been in touch with Washington and has raised Canadian concerns with American officials. Many of those concerns were addressed by the action that was taken over the weekend.

### REQUEST THAT PRIME MINISTER INTERVENE

Mr. Nelson A. Riis (Kamloops-Shuswap): Mr. Speaker, my supplementary question is again addressed to the Prime Minister. It seems to me that Canada has taken the long-distance feeling on a number of issues, including the 300 American protectionist Bills and most recently this weekend's decision. Why do we not move away from the long-distance feeling with the United States and ask the Prime Minsiter to pick up the telephone, call the President of the United States and start representing the interests of Canadian workers and producers on an issue as important as this one?

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, I would hope that within the next couple of days the Hon. Member will have occasion to rise to his feet to applaud the Government for continuing to do prescisely that.
