ociety may in any two number of tion in the rubscribing each each not less than Five Shillings annually to the funds thereof, to raise an aggregate sum of not less than Ten Pounds, and a true copy of the said Declaration certified by the President or Vice-President of such Society, shall be forthwith transmitted to the County Society.

XXXIV. The said Societies shall hold their Annual Meeting Annual Meetin the month of January in each year, and shall elect a Presi-ings thereof. dent, Vice-President, Secretary and Treasurer, and not fewer than three or more than nine Directors.

XXXV. The said Officers and Directors shall prepare and Reports by present to the Annual Meeting of the Society, a Report of their their Officers. proceedings during the year, in the same manner as hereinbefore directed for County Societies, and containing information under the same heads; and shall transmit a true copy thereof, certified by the President or Vice-President, to the Secretary of the County Society, in time for the Annual Meeting thereof in the month of February.

XXXVI. Township or Branch Society shall not forfeit any right to a share of the Public Grant for not making a full Report for such year; Provided also, that the Directors of the Society of the Township in which the County Exhibition shall be held, shall for that year be ex officio Directors of the County Society.

XXXVII. When the President and Secretary of the As to Govern-Board of Agriculture shall certify to the Minister of Agricul- ment grant to ture, that any County Society has sent to the said Board ties. Reports and Statements as required by this Act, for the year then last previous, and shall also certify that the Treasurer or other Officer of the said Society, has transmitted to the said Board an Affidavit, which may be in the form of the Schedule B to this Act annexed, and may be sworn to before any Justice of the Peace who is hereby authorized to receive the same, stating the amount subscribed for that year, and paid to the Treasurer of the County Society by the Members thereof,
