NORTH SHORE MEN IN CASUALTY LISTS. Interesting items of news from the battlefield in Europe continue to come through to New Brunswick of the sons who left in the first contingent.

Mrs. Chesley Armstrong (N. B.), yesterday received notification that her husband had been wounded with the 16th battalion.

Another New Brunswick man in yesterday's list was Sgt. Edmund Sargent, of Campbellton (N. B.).

Corp. J. P. Ryan of St. John, has been in the fighting for several months. He saw three years' service with the 1st Canadian Mounted Rifles in the South African war, and at the close of that war he joined the Royal North West Mounted Police in which service he spent six years. In a letter to his father, received here on Saturday, he announced that he had just been transferred from the 10th to the 14th battalion.

A letter received by Mrs. W. Gantzer, of 74 Chapel street, from her son, who is now in the Royal Hospital, Richmond, Surrey (Eng.), tells of his condition, and speaks of the kind treatment he has been given. His condition is slightly better, he says. An X-ray examination had disclosed five small pieces of shrapnel in his right forearm and another in his right hand. He was also bruised on one of his legs.

Mrs. Margaret Beaubien, of 422 Main street, received a letter from her husband, Corporal Bonhomme, who is with the Canadian forces in France. He said he was well and had escaped injury up to that time. He had been appointed special interpreter for the battalion signallers. In the letter was enclosed a Flemish prayer book which he found on the battlefield after the three engagements at Ypres.

One of the narrowest escapes so far chronicled in the letters from the boys with the 8th Anderson's (Montn) Battery was that of Gunner William Walter Gunn, son of Mr. and Mrs. A. G. Gunn, who would have lost an arm but for the presence of a small shell fragment. The watch was shattered but turned aside the bullet. After telling the story he adds:

"I have had dozens of very narrow escapes from death and have seen some awful sights—the worst slaughter of men and horses I have ever seen—and I see again. I have been in places that I never expected to get out of, but I did, and I guess I can thank the Lord for it."

Private Dan O'Keefe of Campbellton, killed in the battle of Ypres was the third son of the late Mr. O'Keefe, who was a well-known hotel keeper. He was born 25 years ago and joined the 12th battalion of the first contingent, and his brother, Art, being among the first volunteers. After arriving in England, he is in company with others from Campbellton was drafted as reinforcements to the front as signallers. Private O'Keefe is mourned by his mother, three sisters, Mrs. W. S. Montgomery, Mrs. Dow Van Horn and Miss Maud, and three brothers, Art, serving in the Princess Pats and Hugh and Ray at home.

Patrick Gallagher of the Minto Hotel, Moncton, yesterday received a telegram from Ottawa, stating that his son, Pte. John Walter Gallagher of the 18th battalion, had been killed in action on April 24. He enlisted in Montreal with the 8th Royal Scots regiment, which was subsequently designated the 18th battalion and brigaded with the other Canadian Highland regiments.

A most welcome letter from Lance Corporal Byron Greer was received by his mother, Mrs. M. Greer, of Hampton. He says: "We have had our first baptism of fire. I have been in the thickest of battle. I have never heard by this time the good name we have won for Canada. We don't get enough letters from friends. Please send us some chocolates."
