A WOMAN EXECUTED.

Hilda Biake, of Brandon, Explates Her Orime at Brandon.

Brandon, Maa., Dec. 27 .- Hilda Blake was hanged here in the jail yard this morning for the murder of Mrs. John Lane. She showed the same firmness in stepping on to the platform of the scaffold as she had shown ever since she confessed her crime. When asked if she had any extrement to make the confessed here.

if she had any statement to make she said: "Nothing."

Hilda Blake was a domestie servant who shot and killed Mrs. John Lane, of this place, by whom she was employed, early in July last. The servant and her mistress were alone in the house, and the latter was engaged in putting up curtains. On being shot Mrs. Lane rushed screaming to the lawn, where ber little children were having a ten party, and fell dead. Hilda Blake, on being questioned, said a tramp had come to the house and asked for food; that Mrs. Lane told him she was too busy to attend to him, and that he then fired at her and ran away. The man the girl said, spoke like a foreigner. The whole town turned out to look for the murderer, and a Galician immigrant was arrested but moved his investment. was arrested but proved his innocence and was released. On July 10 Hilda Blake was arrested and identified as a girl whe on June 20 had purchased a re-yolver and cartridges while in Winnipeg. After being arrested the girl made a complete confession and begged to be allowed to commit suicide. She said she had purchased the revolver with the intention of killing herself, but that in a fit of insane jealousy she went up to Mrs. Lane, kissed her, and then shot her. First she fired at her head, then as her mistress ran away, she shot her in the back, the second shot having fatal effect. Hilds Blake was 22 years of age, and was sent to this country by an English workhouse alone with other children. She was an orphan.
