FOXY CITIZENS HIDING LIQUOR

In Six Houses Booze Bandits Failed To Find A Drop.

WINDSOR, May 30.—Following a lull in the operations of a liquor bandit gang, six homes on McKay avenue were reported entered sometime during the week-end. The bandits made an attempt to break into two more homes on Cameron avenue and one on London street west. Due to precautions of residents, who have moved small stores of liquor to bedrooms and attics, the case goes to be not in cellars, and the burglars are said to have failed to secure a single drop. A fishing pole valued at \$10 was reported stolen from one home. At another home a resident is said to have hidden his stock of liquor under his bed. Chief Daniel Thompson stated today that extra surveillance will be exercised on residential streets.

Jumped His Bail.
George Mehrkameper, Petite Cote, jumped his bail of \$600, and failed to appear in court today on a charge of keeping a liquor den. Magistrate Gundy imposed a fine of \$500 and costs, and also made provision for a jail term of three months along with the fine. It was stated in court that Mehrkameper had gone across the line. It is also said that he is wanted in Michigan.

GARFIELD'S MOTHER IS NOT ALLOWED TO EVEN SHAKE HIS HAND

Authorities Are Taking No More Chances With Desperado.

RELATIVES WANT BODY

Brother Makes Personal Appeal To Attorney-General For Remains.

[Special To The Advertiser.]
WOODSTOCK, May 30.—The strict order issued by the sheriff that no one visiting Norman Garfield shall even shake hands with him, let alone enter his cell, has met with a vigorous protest from his mother. The mother, with a daughter from Toronto, with other members of the family visited the prisoner yesterday. It was the first visit of Mrs. Guy, the sister from Toronto. When she approached the cell door to shake hands with him, she was restrained by one of the provincial police who was on duty at the time. Even the mother was not allowed to shake the hand of her son. The orders deeply affected the mother, and today she appealed to Montagu Nesbitt, an effort to have the stringent rules rescinded.

Obeying Orders.
Mr. Nesbitt telephoned to the sheriff, who in turn informed Garfield's mother that he was simply carrying out orders received from Toronto.
"Most un-British treatment, to say the least—more like one would expect in Germany," was Mr. Nesbitt's comment.

He could not understand how any guard, order or no order, could stand at a cell and refuse to let a sister, seeing her brother for the last time, refuse to let her shake hands or kiss him good-by.
Mr. Nesbitt, then by letter protested direct to Hon. Mr. Raney, asking that he immediately take action to in some way have the order amended, so that the mother and other relatives might have at least the privilege of shaking the hand of the man sentenced to die on Thursday.

A Trying Day.
Garfield continues to display an absolute coolness. His guard reported today that he slept through the entire night without waking up. Today was a particularly hard one on him, for early today two carpenters from Toronto started work on the scaffold. Hangman Ellis is superintending the construction. The scaffold is being built in a far part of the jail, apart from that occupied by Garfield, still the bang and noise of the carpenters' tools could be heard clearly by those passing the jail. When completed it will be taken in parts to the west yard, where the execution will take place.

As to what disposition will be made of Garfield's body after he has satisfied the law's claims upon his life, remains to be seen. The law requires that the body of an executed murderer must be buried within the confines of the jail premises, unless by special permission of the attorney-general the remains shall be delivered to relatives upon their request.
Today the brother in Toronto applied personally to the attorney-general in an effort to secure the body.

MORE MEN SEEKING DIVORCE THAN WOMEN

Out of 610 Granted 354 Have Been Asked by Husbands.

OTTAWA, May 30.—(By Canadian Press).—In view of the stubborn battle being fought the House of Commons against granting a divorce to Alphonse Lemoyne de Martigny of Montreal, it is interesting to note that since Confederation the divorce committee of the Senate has granted 610 divorces, 354 of which were on applications of husbands and 256 on the application of wives.

During this period Ontario has led the way with a total of 456 divorces against 33 from Quebec, 27 from Manitoba, 19 from Saskatchewan, 21 from Alberta, 2 from British Columbia, 1 from Prince Edward Island and 7 from the Northwest Territories.
In the ten-year period from 1907 to 1917 only 7 divorces were granted. In the ten years ending in 1920, only 19 were granted. The number jumped to 94 for the period, 1919 to 1920, but from 1919 to 1920 the number reached the total of 236. That the next ten years' period will establish a new high record is shown by the fact that in 1920 alone 109 divorces were approved, while if all the divorce recommendations of the committee carry this year, and with the one exception there is every reason to suppose they will, the total for 1921 will reach 110.

MINISTER INSPECTS WATERLOO HIGHWAYS

Tollgate Will Be Removed and Roads Improved.

GALT, May 30.—Hon. F. C. Biggs, minister of public works, Deputy Minister W. A. McLean and two engineers today made a tour of inspection of the roads in Waterloo County, proceeding from Galt to Elmira. Here they were met by deputations from Kitchener, Preston and Galt councils and representatives of public bodies. The minister decided that the old tollgate at the city limits on the Hamilton road should be removed, as it was an obstruction to traffic. It was also agreed that the department would do some work on the stone road for a distance in Galt. It is the main highway from Hamilton through to the north. It is designed to make the road in and out of Galt 80 feet wide, and therefore it will have to be widened. The Galt-Preston roadway will therefore for the time being only be repaired.

FIRE HALL FOR THORNDALE.
THORNDALE, May 30.—As a result of the village trustees having purchased the present location of the Bank of Montreal for a fire hall, the bank has had to secure a new location. The building bought by the trustees will be re-modelled shortly.

TRIED TO BURN HALL.
DUBLIN, May 30.—During disorders at the curfew hours Sunday an unsuccessful attempt was made to burn Liberty Hall. The incendiaries who were discovered, decamped. The fire was extinguished before serious damage resulted.

SUING RANEY FOR \$50,000

Walter Robb of Cayuga Takes Action Against Attorney-General.

HAMILTON, May 30.—Legal proceedings against the attorney-general of David Hastings of Dunnville, Ont., suspended police magistrate, against Attorney-General W. E. Raney at the time of the investigation by John A. Patterson, K.C., Toronto, of Hastings' administration of the O. T. A., were started today, when a writ was issued by Walter Robb of Cayuga against Hon. Mr. Raney for \$50,000 damages.
The action is the outcome of charges which Hastings states were made against him by the attorney-general when a Dunnville deputation waited upon the attorney-general and asked for Hastings' reinstatement as magistrate. The alleged charges were not on the list furnished to Commissioner Patterson in connection with the investigation.

Mr. Patterson's report was handed to the Government just before the prorogation of the last session of the Legislature. It was a recommendation that Mr. Hastings be reinstated in his resignation. The resignation has not been forthcoming, and so far as is known, it has not yet been asked for.

VOTE \$6,782,195 FOR CUSTOMS DEPT.

North Perth Member Criticizes the Present System of Retirement.

OTTAWA, May 30.—(By Canadian Press).—The House of Commons today voted remaining supply for the department of customs and inland revenue.

The total vote was one of \$6,782,195, covering salaries, contingencies, stationery, revenue cruisers and miscellaneous, an increase of \$129,086 over last year.

The committee adopted a motion by Hon. W. L. Mackenzie King to consider the items separately. The first was \$5,489,815, salaries and contingencies of the several ports of the Dominion.
Mr. Wilmour gave figures of customs collections for the last twenty-five years. In the year 1896-97 customs revenue had been \$12,591,996; expenditures \$945,245, and percentage of cost of collections 4.75 for the nine months of the present fiscal year receipts had been \$14,756,022, expenses \$3,699,772, percentage of cost of collection 25.09. For inland revenue the percentage of cost of collection in 1917-18 had been 6.3; in 1920-21, 1.68.

Morphy Criticizes.
H. B. Morphy (Perth North) found fault with the system of retirement now in operation. It seemed that a man with ten years' service to his credit was entitled to an annual pension of one-third of his average salary for the last three years, while a man having served a few days less than ten years would receive only \$1,000 in all. Mr. Morphy appealed for a more equitable scale of pension.

Hon. A. Calder explained that nine years and six months was accounted as ten years of service. "You must draw the line somewhere," he said.
D. D. McKenzie objected to the provision in the item under which officers are paid for overtime, notwithstanding the provisions of the civil service act. He did not think it right for the minister to ask Parliament to give him authority to violate the law of the country. The item carried.

SEEKING RELEASE OF LORNE HELMER

Petitions Are Being Very Largely Signed in Norfolk.

[Special To The Advertiser.]
SIMCOE, May 30.—A petition for the release of Lorne Helmer of North Walsingham, who is serving a sentence of 18 months in Burwash for the Killing of James A. Learn, an aged farmer, about a year ago, is being circulated in Norfolk County. It is being largely signed. The petition states that the evidence at the trial showed very provocative circumstances, and that Mr. Justice Kelly, who sentenced him, stated at the trial that if he consulted his own private feelings he would have allowed Helmer to go.
During Helmer's absence overseas, his mother leased the family homestead to Learn. When Helmer returned he attempted to take possession of the farm, and in the melee which resulted he hit Learn in the face with his flat. Doctor's testimony at the trial showed that Learn did not die as a result of the blow, but of heart-failure. Following Learn's death, Helmer, and his young brother took the farmer's body and left it behind a barn for three days. Later it was discovered in a sink hole by a ravine, when the younger brother mentioned some of the circumstances.

IRISH CONSTABLE SENTENCED TO DEATH
DUBLIN, May 30.—Constable William Wittell, who recently was court-martialed on a charge of having killed Magistrate Robert Dixon in County Wicklow last February, has been sentenced to death. Dixon was shot dead near Dunlavin and his son James was seriously wounded at the same time. The men were resisting armed bandits, who demanded money from them.
Two civilians named Mayer, also have been sentenced to death for the murder of Police Sergeant Wallace at Knocklong, in May, 1919.

'SHORT' BOXES NOT ALLOWED

Minister of Agriculture Declares Public Must Be Protected.

OTTAWA, May 30.—(By Canadian Press).—Hon. S. F. Tolmie, minister of agriculture, in the House this afternoon declined to accede to appeals that the "short" berry boxes be permitted again this season. The question was discussed on a motion to go into committee of supply. J. A. C. Ethier (Two Mountains) said it was impossible to get the legal box in the province of Quebec in sufficient quantities to handle the large crop of berries expected.

Col. J. A. Currie (Simcoe), had a distinct recollection that last year vast quantities of berries went to waste because of the difficulty in securing boxes. The "short" box was really the American quart, or only four-fifths of the Canadian quart. Rather than allow the fruit to go to waste this year it might be advisable to extend the privilege of using the smaller box. The time must come, however, when the Government would be compelled to put its foot down. Consumers must be protected, and it must be remembered that there were two parties to be given a fair deal. If the smaller box was again allowed, the berries should be sold at a corresponding price.

Hon. S. F. Tolmie minister of agriculture, reminded the House that the agreement to use the larger boxes was reached on May 24, 1919, and after a conference with the berry growers. One whole year was permitted to elapse before this was to go into effect, and then the privilege of using the smaller boxes was extended into 1920. In 1919 all the growers knew it would be necessary to use the larger box. Ample time had elapsed, and there was no reason why the act should not be called into effect.
