6. Resolved, That a sum not exceeding One hundred thousand dollars be granted to His Majesty for Public Works—Income—Dredging—British Columbia—Further amount required, \$50,000; Dredging—Ontario and Quebec—Further amount required, \$50,000, for the year ending 31st March, 1918.

7. Resolved, That a sum not exceeding Eleven thousand dollars be granted to His Majesty for Public Works—Income—Slides and Booms—Gatineau River—New boom, for the year ending 31st March, 1918.

8. Resolved, That a sum not exceeding One hundred and twenty-one thousand dollars be granted to His Majesty for Public Works—Income—Roads and Bridges—New bridge to replace present Union Bridge over Ottawa river between Ottawa and Hull, \$120,000; Smith Portage Road, N. W. T.—Improvements, \$1,000, for the year ending 31st March, 1918.
