Order in Council, P.C. 398, dated February 19, 1936: authorizing payment to the province of Alberta of the sum of \$133.02—compassionate allowance to Mrs. Dorothy Campbell.

Order in Council, P.C. 399, dated February 19, 1936: authorizing changes in schedules of relief works in the province of New Brunswick, pertaining to construction of highways, which were approved by Orders in Council, P.C. 3082, dated October 4, 1935, and P.C. 3480, dated November 7, 1935.

By Mr. Reid:—Order of the House for a Return showing:—

1. What lawyers and law firms, if any, of the city of Vancouver, British Columbia, were retained by the Federal Government of Canada during the period from August 1, 1930, until December 31, 1935?

2. Sums paid by the Federal Government and all departments thereof to each such lawyer and law firm.

3. Services rendered by each lawyer and law firm for the amounts so paid to each.

By Mr. Boulanger:-Order of the House for a Return showing:-

1. According to the records of the Post Office Department, from August 7, 1930, to October 29, 1935, how many times the Postmaster General exercised the discretionary powers vested in him under Section 67 of the Post Office Act, whereby mail contracts are not always awarded to the lowest tenderer.

2. According to the records of the Post Office Department, from August 7, 1930, to October 29, 1935, how many mail contracts were awarded to persons who, not being originally the lowest tenderers, were allowed to reconsider their tender and reduce the figure thereof.
