Mr. Garson: Typical tactics of the opposition-Hong Kong, Bren gun, North Star.

Mr. Drew: Mr. Speaker, since the Minister of Justice (Mr. Garson) is so interested in these proceedings, I should like to deal with certain activities of the government for which I assume he has accepted responsibility. A great deal has been said about the theft of a document. The Royal Canadian Mounted Police were used to conduct an inquiry. The Royal Canadian Mounted Police were directed to conduct an inquiry into what? Into anything affected by any federal law? No. The Minister of Justice makes that quite clear now. They conducted an inquiry and as a result the Minister of Justice has now advised that if anything is to follow it must be at the instance of Mr. Currie or the printing firm from which, according to him, this paper was removed.

Mr. Garson: I wonder if my hon. friend would identify the statement or material upon which he bases the last remark he has made.

Mr. Drew: Oh, Mr. Speaker, the Hansard record is adequate and I leave it at that.

Mr. Garson: Quote it then.

Mr. Rowe: He has been quoting it all afternoon to your shame.

Mr. Garson: If it is in Hansard and he is depending upon it, let him quote it.

Mr. Speaker: The Leader of the Opposition (Mr. Drew) is not required to answer questions. It is a matter entirely within his discretion.

Mr. Garson: On a question of privilege, I say that my hon. friend's statement is without foundation, and if he has the evidence he will cite it.

Mr. Drew: The authority for it is the long and evasive speech made in the house by the Minister of Justice on this very subject.

An hon. Member: Right.

Mr. Drew: The minister says "right".

Mr. Garson: No, no.

Mr. Rowe: Some other member of the government.

Mr. Drew: Another member of the government-

Mr. Fournier (Hull): No, no, not of the government.

Mr. Drew: Then, Mr. Speaker, what has just occurred indicates the desirability of those who have intelligent remarks to make getting on their feet to make them.

Some hon. Members: Hear, hear.
