TEXTILES—POLICY OF COMMISSION—CONSULTATIONS RESPECTING IMPORTS

Mr. André Fortin (Lotbinière): Mr. Speaker, I wish to direct a question to the hon. Minister of Industry, Trade and Commerce.

In view of the overwhelming importance taken by imports in the textile industry and in view of the recent announcement by the minister about a new textile commission, I wish to ask the minister whether he went into consultations with executives of Canadian textile industries or if this action stems merely from a unilateral initiative on the part of the government?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): Mr. Speaker, the new textile policy is the result of an inquiry which has been underway for 18 months. During this period, consultations were held with all interested parties, including management, labour and provincial authorities. I believe there is no question about it; everybody agrees that a maximum of consultations were held.

Mr. Fortin: Mr. Speaker, I have a supplementary question for the hon. Minister of Industry, Trade and Commerce.

Could he tell us whether those consultations have taken place during the 18 months in order to inform the members on the attitude of the leaders of the industries concerned towards the textile problems?

Mr. Pepin: Mr. Speaker, a statement on the textile policy was made in this House in May last. Certain administrative measures have already been taken and announced, including the establishment of a commission. Yesterday, the President of the Privy Council tabled a bill on textiles. This policy is therefore in the process of being completed.

In so far as the attitude of business leaders and unions towards the policy is concerned, I believe they have complete freedom to express their views. A majority of those who have done so up to now said that they felt the policy had much merit, but that before making a definite assessment they would wait until the results are known.

TREE FRUIT INDUSTRY—MEASURES TO ARREST VIRUS INFECTION
