Inquiries of the Ministry

are masters of the illusionary pricing technique, and often control products from farm to store shelf to the detriment of the consumer and, if so, would he consider making a grant available so that this booklet could be widely distributed across Canada?

Mr. Speaker: I suggest to the hon. member that a question such as this one should normally be put on the order paper. But the question has been asked and the minister might reply briefly because we have almost run out of time.

Hon. Robert X. Andras (Minister of Consumer and Corporate Affairs): Mr. Speaker, now that the hon. member's comment and the booklet have been brought to my attention, I will examine them with great interest.

Mrs. MacInnis: If, on examination, the minister does not want to do this, will he consider an investigation into the control by the supermarkets of products from farm to grocery shelf?

Mr. Speαker: Order, please. That is a hypothetical question or a representation.

Mrs. MacInnis: On a point of order, Mr. Speaker, this is not a representation. It is a question that I am asking. I am asking if the minister will conduct an investigation into the control by supermarket chains of products from farm to grocery shelf? There is a question mark at the end of that, Mr. Speaker.

Mr. Speaker: I suggest that my impression, gained over the years, is that all representations have a question mark at the end when they are made during the question period.

CANADA LABOUR CODE

CONSTITUTIONALITY OF AMENDMENT DEFINING FISHERMEN AS INDEPENDENT CONTRACTORS— CONSULTATION WITH CERTAIN PROVINCES

Mr. James A. McGrath (St. John's East): Mr. Speaker, I wish to direct a question to the Minister of Labour. Has he consulted with the provinces of Nova Scotia, Newfoundland and British Columbia on the provisions of Bill C-183—I am thinking especially of clause 107(1)—has he also consulted with the fishermen and, if not, will he do so?

Hon. Martin P. O'Connell (Minister of Labour): Mr. Speaker, there have been very extensive consultations with the fishermen and the Fisheries Council. The standing committee is currently sitting and has heard both of those bodies. I am not in a position to answer this afternoon on whether or not there were consultations with the provinces.
