## **Order Paper Questions**

That 15 members of the House of Commons to be designated at a later date be members on the part of this House on the Special Joint Committee;

That the committee have power to appoint from among its members such sub-committees as may be deemed advisable and necessary and to delegate to such sub-committees all or any of their powers except the power to report directly to the House;

That the committee have power to sit during sittings and adjournments of the House of Commons;

That the committee have power to send for persons, papers and records, and to examine witnesses and to print such papers and evidence from day to day as may be ordered by the committee;

That the committee have power to adjourn from place to place within Canada;

That the committee be empowered to retain the services of advisers to assist in its work; and that it also be empowered to retain the professional, clerical and stenographic help as may be required;

That the committee submit their report not later than July 31, 1975;

That the quorum of the committee be 12 members whenever a vote, resolution or other decision is taken, so long as both Houses are represented and that the joint chairmen be authorized to hold meetings, to receive evidence and authorize the printing thereof, when 6 members are present so long as both Houses are represented; and

That a message be sent to the Senate requesting that House to unite with this House for the above purpose, and to select, if the Senate deems it to be advisable, members to act on the proposed special joint committee.

2. Did the Prime Minister make a statement to the Press on Tuesday, October 1, 1974 to the effect that it is "pure fiction" that Canada will pursue an activist left wing role in foreign affairs?

3. Did the Secretary of State for External Affairs make a statement in an interview with newspaperman Duart Farquharson confirming that Canada will pursue an activist left wing role in foreign affairs?

4. What are all the reasons for these apparent discrepancies?

5. Will the Prime Minister, Mr. Ivan Head and the Secretary of State for External Affairs be meeting together in the near future for the purpose of arriving at an agreed on foreign policy for Canada and, if so, will this policy be, or will it not be, an activist left wing role in foreign affairs?

6. What other countries have similar arrangements?

7. What department of government and which Ministers are responsible for the conduct and operation of such programmes?

Hon. Mitchell Sharp (President of the Privy Council): I am informed by the Department of Manpower and Immigration as follows: 1, 2, 3 and 4. Persons entering Canada temporarily as a result of a cultural agreement between the Government of the French Republic and the Government of the Province of Quebec must simply fulfil the immigration requirements appropriate to their category of entry. The Department of Manpower and Immigration treats each entrant as an individual case, therefore no group information or statistics are available for persons related to this agreement.

5. The Department of Manpower and Immigration provides no financial assistance in this regard.

6. The Government of Canada has no similar agreements with any country.

7. The Department of Manpower and Immigration is concerned with this program only insofar as ensuring that individual members meet the appropriate immigration requirements.
