MONITORING OF AND COMPENSATION FOR WORKERS EXPOSED TO ASBESTOS HAZARDS—MOTION UNDER S.O. 43

That the government at once set up procedures to identify all the employees of wartime defence plants who may be similarly at risk from asbestos exposure, arrange to have them monitored for the appearance of related problems, and compensate them adequately for the suffering involved. This compensation should, of course, include the widows and families of those who have already died from such problems.
