#### **INVESTMENT CANADA ACT**

#### MEASURE TO ENACT

The House resumed consideration of Bill C-15, an Act respecting investment in Canada, as reported (with amendments) from the Standing Committee on Regional Development; and Motions Nos. 8, 12, 32, 63, 69, 74 and 75 (Mr. Langdon) (p. 4242).

Mr. Fernand Robichaud (Westmorland-Kent): Mr. Speaker, I had a few minutes left yesterday when the House was debating the Bill, and particularly the amendments. I was saying how important employment is back home and that we must ensure that this Bill and these amendments do protect our jobs. I was referring to recent riots in our region because people thought or expected that their jobs would be taken away from them. Why riots? Quite simply because there had been no consultation, because the people, the contractors had failed to talk to the workers and discuss the issue with them. Unions and workers were cornered and it was indeed the only means left to them to protest against disappearing jobs. Because machinery was taking jobs away from manual labour, those people reacted violently. I can tell the House that with 2,000-odd people involved, it was not a pretty sight.

Well, Mr. Speaker, that is something we might witness again if the House rejects the proposed amendments, with the result that new companies setting up shop in our regions might
